Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: CIBC Emerging Markets Fund (referred to as the *Fund*) seeks to provide long-term growth through capital appreciation by investing primarily in equity securities of companies operating in or earning significant revenues from an emerging country. An emerging country is any country included in the MSCI Emerging Markets Index.

Investment Strategies: The Fund uses a bottom-up stock selection approach, integrating traditional and quantitative fundamental research. The approach seeks to identify securities that are trading at attractive relative valuations, exhibiting sustainable positive fundamental change, and have earnings estimates revisions. This bottom-up stock selection also drives country and sector positioning.

Risk

The Fund is an emerging markets equity fund that is suitable for long term investors who can tolerate medium to high investment risk.

For the period ended December 31, 2023, the Fund's overall level of risk remained as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio sub-advisor is Victory Capital Management Inc. (referred to as the *Sub-Advisor*). The commentary that follows provides a summary of the results of operations for the period ended December 31, 2023. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 6% during the period, from \$797,692 as at December 31, 2022 to \$845,484 as at December 31, 2023. Positive investment performance was partially offset by net redemptions of \$35,767, resulting in an overall increase in net asset value.

Class A units of the Fund posted a return of 7.5% for the period. The Fund's benchmark, the MSCI Emerging Markets Index (referred to as the *benchmark*), returned 7.3% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

Inflation and tightening global monetary conditions drove investor sentiment and performance in emerging markets, as they did more broadly. China loomed large amid concerns over the economy's near-term recovery, specifically with the reopening from COVID-19 lockdowns. Other issues included Latin American politics and the ongoing de-risking of global supply chains, which fuelled near-shoring.

Stock selection in the consumer discretionary, information technology and financials sectors contributed to the Fund's performance. Within consumer discretionary, underweight positions in select Chinese companies also contributed. Information technology thrived on expectations of a sector earnings recovery and excitement about artificial intelligence (referred to as *Al*). The Fund had an underweight exposure to the financials sector, which faced broad macroeconomic pressures as the current interest rate cycle neared its peak. Holdings in the fiancials sector remained resilient due to strong fundamentals.

The top individual contributors to the Fund's performance were Gold Circuit Electronics Ltd., WiWynn Corp. and Cholamandalam Investment and Finance Co. Ltd. Gold Circuit Electronics stock surged on Alrelated demand and networking upgrades. WiWynn's revenues rose from server orders from Amazon.com Inc. and more Al server projects for Meta Platforms Inc. and Microsoft Corp. After a sell-off through July and August, Cholamandalam reached a new high.

An overweight exposure to the health care sector and underweight to Saudi Arabia, as well as stock selection in the materials sector, detracted from the Fund's performance.

The top individual detractors were WuXi Biologics (Cayman) Inc., Alibaba Group Holding Ltd. and Anglo American PLC. WuXi Biologics sold off after the company cut earnings guidance for late 2023 and projected a challenging early 2024. Alibaba Group Holding shares fell on news the company would not spin off its cloud group and on reported rumors that the company co-founder would sell shares. Anglo American fell on a drop in new starts in China and concerns about a global recession.

The Sub-Advisor added Vale SA, NetEase Inc., Ternium SA, UltraTech Cement Limited, Emaar Properties PJSC and New Oriental Education & Technology Group Inc. to the Fund. The Sub-Advisor expects Vale's

product prices to recover on Chinese government action to restore the property market. NetEase should enjoy a rebound in China's online gaming sector (88% of total company revenue in 2022), in the Sub-Advisor's view. Ternium is benefiting from strong North American demand for its flat steel and from the region's supply chain near-shoring away from China. India's UltraTech Cement is seeing positive demand trends and a drop in energy prices. Emaar Properties' key United Arab Emirates property market is expected to grow over the next four to five years. New Oriental Education & Technology Group is seeing rising profitability and market share after the industry restructured.

The Fund holdings in Samsung Electronics Co. Ltd., Taiwan Semiconductor Manufacturing Co. Ltd. and Petróleo Brasileiro SA were increased. The Sub-Advisor expects both Samsung and Taiwan Semiconductor Manufacturing will see improved results on an anticipated technology market upturn. Petróleo Brasileiro is expected to deliver positive results from its investments and fuel pricing policy.

The Sub-Advisor sold the Fund's holdings in JD.com Inc., Meituan, Infosys Ltd., Cholamandalam, Saudi National Bank, Absa Group Ltd., Credicorp Ltd., SK Hynix Inc. and Hon Hai Precision Industry Co. Ltd. For both JD.com and Meituan, competition is increasing, and the Sub-Advisor believes e-commerce growth may disappoint high expectations. All leading growth indicators suggested weaker growth ahead for Infosys. The Fund took profit after Cholamandalam stock reached a new high. Saudi National Bank faces a continued drag on performance on its stake in Credit Suisse. Absa Group's 2023 forecasts were downgraded after warnings of increased sovereign investment impairments. Credicorp faced worse political tensions and banking statistics than regional peers. Less competitive technology and more geopolitical risk led the Sub-Advisor to replace SK Hynix with Samsung. Hon Hai Precision Industry appears too dependent on what could be a weaker near-term iPhone component business.

The holdings in JYP Entertainment Corp., China Resources Land Ltd. and PetroChina Co. Ltd. were decreased. The Sub-Advisor took profit on JYP Entertainment and PetroChina following share price rallies. The Fund's exposure to China Resources Land was pared as sentiment in China declined.

Recent Developments

Effective April 27, 2023, Bryan Houston was appointed Chair of the Independent Review Committee.

The COVID-19 pandemic and the Russia-Ukraine war have disrupted the global economy and financial markets in unprecedented and unpredictable ways. This has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses and financial markets. Inflation has increased in many markets across the globe, leading central banks to raise interest rates in order to counter rapidly rising prices. These factors may adversely affect the performance of the Fund. The Manager continues to monitor ongoing developments and the impact to investment strategies.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager

CIBC is the Fund's manager (referred to as the *Manager*). CIBC receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in the section entitled *Management Fees*. The Manager compensates its wholesalers in connection with their marketing activities regarding the Fund. From time to time, CIBC may invest in units of the Fund.

The Manager pays the Fund's operating expenses (other than certain fund costs) in respect of the class of units of the Fund(except class O unit), which may include but are not limited to, operating and administrative costs; regulatory fees; audit, and legal fees and expenses; trustee, safekeeping, custodial, and any agency fees; and investor servicing costs and costs of unitholder reports, prospectuses, Fund Facts, and other reports, in exchange for the Fund paying a fixed rate administration fee (plus applicable GST/HST) to the Manager with respect to those class of units. For class O units, no fixed administration fee will be charged. The Manager pays the Fund's operating expenses (other than certain Fund costs) allocated to Class O units of the Fund. The fixed administration fee payable by the Fund, may, in any particular period, exceed or be lower than the expenses we incur in providing such services to the Fund.

Trustee

CIBC Trust Corporation, a wholly-owned subsidiary of CIBC, is the Fund's trustee (referred to as the *Trustee*). The Trustee holds title to the Fund's property (cash and securities) on behalf of its unitholders.

Portfolio Advisor

The portfolio advisor provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI, a wholly-owned subsidiary of CIBC, is the Fund's portfolio advisor.

Distributor

Dealers and other firms sell the units of the Fund to investors. These dealers and other firms include CIBC's related dealers such as the principal distributor, CIBC Securities Inc. (referred to as *CIBC SI*), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (referred to as *CIBC ISI*), the CIBC Imperial Investor Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC SI, CIBC ISI, and CIBC WM are wholly-owned subsidiaries of CIBC.

CIBC may pay trailing commissions to these dealers and firms, in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor and any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor and any portfolio sub-advisors, to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income and other securities and certain derivative products to the Fund. A spread is

the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the type and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor and any portfolio sub-advisors, in partial exchange for processing trades through them (referred to in the industry as "soft dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor and any portfolio sub-advisors, with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a Related Dealer or the Related Dealers) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units in the fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to

advise the Canadian securities regulatory authorities, after a matter has been referred or reported to the IRC by the Manager, if it determines that an investment decision was not made in accordance with a condition imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the Fund's custodian (referred to as the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for the services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or the dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company Inc. (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund, either directly or indirectly, pays CIBC an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CIBC in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses and trailing commissions are paid by CIBC out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CIBC. Refer to the Simplified Prospectus for the annual management fee rate for each class of units. For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended December 31, 2023. These amounts do not include waived fees or absorbed expenses.






Year-by-Year Returns
